## The Charles Blackall Journalist Fund APPLICATION GUIDELINES

**The Charles Blackall Journalist Fund was established under the terms of the Will of Mabel Elizabeth Blackall.**

### **PURPOSE OF FUND**

The purpose of the Fund is to assist in providing residential accommodation for impoverished journalists or ex-journalists. Preference will be given to applicants in financial need who require assistance for current, short-term financial difficulties relating to their accommodation.

### **Grant Application Procedures**

- Applications are reviewed regularly and are accepted from applicants Australia-wide;
- The Trustee, upon the advice of the Advisory Committee, selects successful applicants. The Advisory Committee comprises members of the Journalist Association Section of the Media Entertainment and Arts Alliance;
- Rental agents, mortgage agents and referees may be contacted for verification of details supplied by the applicant.

The Trustee requests that applications include:

- A completed grant application form;
- A one-page letter describing:
  - the reason why funds are being sought;
  - a summary of your fortnightly budget;
  - details of any funding you have received from the Charles Blackall Journalist Fund in the past;
  - and other details regarding your financial situation and that you care to include or think is relevant.
- Confirmation of income details such as a copy of your pension statement, rental agreement or mortgage agreement, (including rental and mortgage agent contact details);

- Brief one page résumé including two referees;
  - One professional;
  - One related to your accommodation matters (i.e. landlord)
- Sample of work (e.g. newspaper article);
- Consent of other persons identified in this application to the disclosure of their personal information.

If you are providing personal information relating to another person it must only be provided if the consent of that person has been obtained.

If any documents provided with your application need to be returned, please include a stamped self-addressed envelope with your application.

The Trustee does not notify applicants of the receipt of their applications. However, the Trustee endeavours to inform all applicants of the outcome of their application within eight to ten weeks of receipt.

The Trustee considers all applications to determine whether the application fits the purposes of The Fund. It reserves its discretion to decline to grant payment. It is the policy of The Fund not to provide reasons for declining an application.

**Applicants should note that where an application is successful, funding is forwarded directly to the rental agent or mortgage agent in relation to which funding has been sought.**
